

Terms and Conditions

Welcome to CTF Xmas Countdown challenge 2020!

Please read these Terms and Conditions carefully because they govern each participant's access to and use of the Services.

1. Agreement to Terms

The following Terms and Conditions ("Terms and Conditions") apply to all participants and others who access the CTF Xmas Countdown Challenge 2020 (hereafter, "Xmas Challenge"). Xmas Challenge is available through the Platform. These Terms and Conditions therefore also apply to your access and use of Platform, including any content, functionality, and services offered on or via the Platform.

By participating in the Xmas Challenge, you accept and agree to be bound and abide by these Terms and Conditions. You may partake in Xmas Challenge only in compliance with these Terms and Conditions. If you do not understand any terms in these Terms and Conditions, please contact us before using the Services.

These Terms and Conditions are binding as of 25.11.2020. We expressly reserve the right to change these Terms and Conditions from time to time without notice to you. You acknowledge and agree that it is your responsibility to review this Application and these Terms and Conditions from time to time and to familiarize yourself with any modifications. Your continued use after such changes will constitute acknowledgment of the modified Terms and Conditions and agreement to abide and be bound by the modified Terms and Conditions.

2. Definitions

A "Visitor" is someone who merely browses Platform but has not registered as a Participant.

A "Participant" is an individual that has registered with us to use our Service and participate in the Xmas Challenge.

Our "Service" represents the collective functionality and features as offered for purposes of the Xmas Challenge to our Visitors and Participants through the Platform.

A "Platform" is a virtual space within which the competition takes place and through which the challenges are available.

All text, information, graphics, audio, video, and data offered through Xmas Challenge Platform are collectively known as our "Content".

3. Rules applying to Xmas Challenge

All of the challenges are located outside the platform. There is no need to attack the platform.

Platform is out of the scope for this competition.

4. Hate speech

We do not allow hate speech because it creates an environment of intimidation and exclusion and, in some cases, may promote real-world violence.

We define hate speech as a direct attack on people based on what we call protected characteristics — race, ethnicity, national origin, religious affiliation, sexual orientation, caste, sex, gender, gender identity, and severe disease or disability. We define attack as violent or dehumanizing speech, harmful stereotypes, statements of inferiority or calls for exclusion or segregation.

We believe that people are more responsible when they share this kind of commentary using their authentic identity. Therefore, we explicitly urge you to spread kindness.

5. Conduct

Your participation in the Xmas Challenge is subject to all applicable laws and regulations, and you are solely responsible for the substance of your communications through the Platform.

6. Intellectual property

By accepting these Terms and Conditions, you acknowledge and agree that all content presented to you is protected by copyrights, trademarks, service marks, patents, or other proprietary rights and laws and is the sole property of us.

You are only permitted to use the content as expressly authorized by us or the specific content provider. Except for a single copy made for personal use only, you may not copy, reproduce, modify, republish, upload, post, transmit, or distribute any documents or information from this Platform in any form or by any means without prior written permission from us or the specific content provider, and you are solely responsible for obtaining permission before reusing any copyrighted material that is available on this Platform.

7. Disclaimer of Warranties, Limitations of Liability and Indemnification

Your participation in Xmas Challenge is at your sole risk. We are not responsible for any damage or harm resulting from participation in the Xmas Challenge, communications, or interactions with other Participants or other Visitors, either through the Services or otherwise. We disclaim all warranties of any kind, express or implied, including, without limitation, the warranties of merchantability, fitness for a particular purpose, and non-infringement.

We are not liable for damages, direct or consequential, resulting from your use of the Application, and you agree to defend, indemnify and hold us harmless from any claims, losses, liability costs, and expenses (including but not limited to attorney's fees) arising from your violation of any third-party's rights. You acknowledge that you have only a limited, non-exclusive, non-transferable license to use the Application. Because the Application is not error or bug-free, you agree that you will use it

8. Term and termination

These Terms and Conditions will become effective when you register and participate in Xmas Challenge or when you start using the Platform and will remain effective throughout use and until terminated by us.

We reserve the right to terminate these Terms and Conditions or suspend your account at any time in case of unauthorized, or suspected unauthorized use of the Application whether in contravention of these Terms and Conditions or otherwise. If we terminate these Terms and Conditions or suspend your account for any of the reasons set out in this section, we shall have no liability or responsibility to you.

9. Assignment

We may assign these Terms and Conditions or any part of it without restrictions. You may not assign these Terms and Conditions or any part of it to any third party.

10. Governing Law

These Terms and Conditions and any dispute or claim arising out of, or related to them, shall be governed by and construed by the internal laws of the Republic of Slovenia without giving effect to any choice or conflict of law provision or rule.

Any legal suit, action, or proceeding arising out of or related to these Terms of Service of the Xmas Challenge shall be instituted exclusively in the federal courts of the Republic of Slovenia.
